- I am a citizen of the Republic of Palau, the Republic of the Marshall Islands, or the Federated States of Micronesia
- I am a lawful nonimmigrant in a temporary status. This includes students, diplomats, tourists, H1B workers, J-1 visitors, and those in other "lettered" temporary classifications.

I am a transgender female who was assigned the sex of male at birth and am not registered with the Selective Service.

I certify that I am not registered with the Selective Service and do not qualify for an exemption as listed above. I understand I will not be eligible for federal and/or state funds, and any aid will be canceled until I register.
